Notice inviting Tender No. 01/T/ELEC 2022-23 of the Director, BRAIPRD, Kalyani, Nadia on behalf of the Governor of the State of West Bengal invites tender for the works detailed in the table below.

2. Eligibility criteria for participation in the tender:

a) The prospective bidder must have electrical supervisors certificate of competency in parts 1, 2, 3, 4, 5, 6(a), 6(b), 7(a), 7(b), 11 or equivalent national supervisor certificate of competency.

b) the prospective outside bidders must have the credential of satisfactory completion as a prime agency during the last 5 (five) years from the date of issue of this Notice at least one work of similar nature having a magnitude of 40 (forty) percent of amount put to tender under authority of state govt./ central govt. State or central govt. undertaking statutory bodies constituted under the statue of the central /state government or equivalent as per order of the principal secretary to the govt. of West Bengal vide Ref. No. 04-A/PW/O/10C-02/14 dt. 18.03.2015.

N.B. : Completion certificate should contain a) name of work, b) name of client, c) amount put to tender, d)schedule month and year of commencement and completion as per work order, e) actual month and year of completion.

c) The prospective bidders must have valid upto date clearance of income tax return /profession tax clearance certificate/ PT (deposit challan)/ Pan card/ GST registration certificate/ Voter ID card for self identification and income tax acknowledgement receipt for latest assessment year.

d) Bidders who meet the minimum qualification criteria will be qualified only if their available bid capacity for electrical work is equal to or more than the total bid value. The available bid capacity will be calculated

as under :

Assessed Available Bid Capacity = (A * N * M - B).

Where

- A = Maximum value of electrical engineering works executed in any one year during the last five years (updated to the price level of the last year at the rate of 8 percent simple interest a year) taking into account the completed as well as works in progress.
 - N = 1

B = Value, at the current price level, of existing commitments and on-going works to be completed during the period of completion of the works for which bids are invited.

Note : The statements showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the

Engineer in Charge.

The bidder at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the bid and entering into a contractor for the work as mentioned in notice inviting tender, before submitting offer with full satisfaction. The cost of visit the site shall be at bidder's own expenses.

8. Technical bid and financial bid both will be submitted concurrently duly signed within the time as specified above.

9. The intending bidder should clearly understand that whatever may be the outcome of the present invitation of bids, no cost of bidding shall be reimbursable by the department. The Director, BRAIPRD reserve the right to reject any or all the applications of purchasing bid documents and /or to accept or reject any or all the offers without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any tender at the stage of bidding.

10. The earnest money of all the unsuccessful Tenderers deposited in favour of the Director, BRAIPRD, Kalyani will be released after agreement with the successful bidder.

11. Contractor shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act 1970(b), Apprentice Act, 1961 and (c) Minimum Wage Act 1948 of the notification thereof or any other laws relating there and the rules made and order issued there under from time to time.

12. During the scrutiny, it comes to the notice to the tender inviting authority that the credentials and or any other paper has been of any bidder found incorrect /manufactured fabricated that bidder will not be allowed to participate in the tender and that application will be rejected outright the Director, BRAIPRD, Kalyani reserves the right to cancel the NIT due to unavoidable circumstances and no claim in this respect will be entertained.

13. Before issuance of the work order the tender inviting authority may verify the credentials and other documents of the lowest tendered, if found necessary. After verification, if it is found that documents submitted by the lowest tenderer is either manufacturer or false the work order will not be issued in favour of the said tenderer.

14. If any discrepancy arises between two similar clauses on different notification, the clause as stated in later notification will supersede former one in following sequence a) form no 2911(i), b) NIT, c) technical bid, d) Financial bid.

15. If the dates fall on holidays or on days of bandh or natural calamity, the dates defer to next working days.

16. In case of inadvertent typographical mistake found in the specific price schedule of rates, the same will be treated to be so corrected as to confirm with the prevailing relevant schedule of rates and or technically sanctioned estimate. Those mistakes cannot be claimed by the bidder during agreement.

17. The intending tenderer is required to quote the rate in figures as well as in words in each item and total will be quoted on BOQ as accepted.

18. Conditional incomplete tender will not be entertained. The accepting authority reserves the right to reject any or all the tenders without assigning any reason whatsoever and he will not be bound to accept either the lowest tender or any of the tenders.

19. Issuance of work order as well as payment will depend on availability of fund and no claim what so ever will be entertained for delay of issuance of work order as well as payment, if any intending tenderers may consider this criteria quoting their rates.
